Applications will be assessed against eligibility criteria as defined in the Community Grants Policy.

Applications can be submitted at any time throughout the financial year to any Council Divisional Offices or via email to Community.Grants@tsirc.qld.gov.au

Allow a minimum of three (3) business days for the Council Officer to review the application and obtain approval.
