## RECOMMENDATION

That pursuant to the Aboriginal and Torres Strait Islander Land Holding Act 2013 (Qld), the Council as Trustee consent to the partial surrender of the Land Holding Act (Katter) lease 715653318 over Lot 191 on SP277431 on Masig.

## **PURPOSE**

This report provides information to Council on the application for a partial surrender of a Katter lease over Lot 191 (JDL Road) Masig.

As trustee for Masig Island Deed of Grant in Trust, it is TSIRC's role to provide consent to a partial surrender of a LHA (Katter) lease. This report is for the Trustee to consider providing consent to the partial surrender of the Katter lease.

## BACKGROUND

- On 10 September, Dick Billy made an application for a Katter lease for both Lot 15 and Lot 191 on SP277431. This Katter Lease was granted to Dick Billy on 4 June 1987. TSIRC is the lessor of the lease.
- 2. In September 1986 Andrew Mene made a valid application for a Katter Lease over Lot 15. However, since this application overlapped the Dick

Billy's Katter lease, this lease cannot be granted while the overlap remains.

- 3. Both Dick Billy and Andrew Mene have passed away, hence beneficiaries are entitled to the Katter leases.
- 4. On 2 December 2020, DATSIP advised TSIRC that it had undertaken consultation with the Billy and Mene families. Agreement was reached that Lot 191 is traditionally Mene family land and should not have been granted to the Billy family in the first place. Both families agree to the partial surrender of the Katter Lease over Lot 191 and have signed the necessary approval. (Attachment 1).
- If the partial surrender is approved by TSIRC, this means that a Katter lease can be granted to Sepoima Warria, Moses Mene, John Mene and Edward Mene for Lot 191.
- 6. The Billy family will have the remaining Katter lease over Lot 15.

Please find enclosed a Titles Form 8 surrender document for the partial surrender of Trustee lease 715653318 for execution by the Torres Strait Island Regional Council in order to progress matters regarding the lease covering lot 191 on SP277431. Specifically, the Billy family would like to surrender lot 191 to the Mene family.

Details of the partial surrender are:

- An application for a Land Holding Act (LHA) lease was lodged by Dick Whittington Billy on 10 September 1986 over what appears to be the area now described as lot 15 on SP277431 and lot 191 on SP27743. This application was deemed valid.
- Trustee Lease 715653318 was granted on 04 June1987 over lot 15 on SP277431 and lot 191 on SP27743.
- Dick Whittington Billy passed away on 26 December 1990.
- The Department of Seniors, Disability Services and Aboriginal and Torres Strait Islander Partnerships (DSDSATSIP) issued a s60 Certificate on 19 March 2020 which identified Mr Elia Billy, Ms Edna Billy and Mr Ingvali Emanuel Billy as beneficiaries in equal interest to Trustee lease 715653318.
- An application for a LHA lease was lodged by Andrew Mene on 10 September 1986, over what appears to be the area now described as lot 191 on SP277431. This application was deemed valid.
- It has not been possible to grant Andrew Mene's lease because lease 715653318 exists over lot 191 on SP277431.
- Andrew Mene passed away on 03 June 1997.
- DSDSATSIP issued a s60 Certificate on 19 December 2019 which identified, Sepoima Vida Warria, Moses Mene, John Mene and Edward Mene as beneficiaries to the LHA entitlement over lot 191 on SP277431.

  Mene land and that lease 715653318 should not have been applied for by, or
  granted to the Billy family over lot 191 on SP277431.
- In respect of Cultural land ownership practice, the identified beneficiaries of Dick Whittington: Mr Elia Billy, Ms Edna Billy and Mr Ingvali Emanuel Billy, and now lessees of lease 715653318 have signed the enclosed Form 8 and Form 20 requesting a partial surrender covering lot 191 on SP277431.
- When the partial surrender over lot 191 on SP277431 has taken effect, the Department of Resources will facilitate the grant of the LHA lease over lot 191 on SP277431 to Sepoima Vida Warria, Moses Mene, John Mene and Edward Mene as beneficiaries to the LHA entitlement over lot 191 on SP277431






