TRUSTEE POLICY -EXPRESSIONS OF INTEREST FOR LEASES WUG (ST PAULS COMMUNITY)

OFFICER RECOMMENDATION:

Council (as Trustee):

- a) note the Expressions of Interest (EOIs) received for 99-year home ownership leases and commercial leases at Wug (St Pauls Community);
- b) note that in accordance with the Council's Trustee Policy decision-making process for Wug;
 - a. the list of the EOIs has been provided to the Divisional Councillor, the Mualgal (Torres Strait Islanders) Corporation RNTBC and Senpolau Kai Kazil Elders Group; and
 - b. public notification of the EOIs is to occur on 24 February 2026; and
- c) for disputed applications, delegate to the Chief Executive Officer the power to take steps to deal with the disputed applications consistently with Council's Trustee Policy, including by providing all people involved in a dispute, details of the dispute, including details of other people involved in the dispute.

Conflicts of Interest

Trustee Councillors are reminded of their obligations to declare, and deal with, prescribed and declarable conflicts of interest under the *Local Government Act 2009 (LG Act)*.

It is noted that a "declarable conflict of interest" is defined in section 150EN of the LG Act as follows:

150EN What is a declarable conflict of interest

Subject to section 150EO, a councillor has a declarable conflict of interest in a matter if—

(a) the councillor has, or could reasonably be presumed to have, a conflict between the councillor's personal interests, or the personal interests of a related party of the councillor, and the public interest; and

(b) because of the conflict, the councillor's participation in a decision about the matter might lead to a decision that is contrary to the public interest.

It is noted that a “**prescribed conflict of interest**” is defined in section 150EI of the LG Act as follows:

150EI When councillor has *prescribed conflict of interest—other*

Subject to section 150EI, a councillor has a prescribed conflict of interest in a matter if—

(a) the matter is or relates to a contract between the local government and the councillor, or a close associate of the councillor, for—

- (i) the supply of goods or services to the local government; or*
- (ii) the lease or sale of assets by the local government*

150EJ Who is a close associate of a councillor

(1) A person is a close associate of a councillor if the person is any of the following in relation to the councillor—

(a) a spouse;

(b) a parent, child or sibling;

(c) a partner in a partnership;

(d) an employer, other than a government entity;

(e) an entity, other than a government entity, for which the councillor is an executive officer or board member;

(f) an entity in which the councillor or a person mentioned in any of paragraphs (a) to (e) for the councillor has an interest, other than an interest of less than 5% in an entity that is a listed corporation under the Corporations Act, section 9.

(2) However, the person is a close associate of the councillor in relation to a matter only if the councillor knows, or ought reasonably to know, about the person’s involvement in the matter.

While it is a matter for Trustee Councillors to form a view about the application of the Councillor conflict of interest provisions in Chapter 5B of the LG Act, it is observed that a Councillor holding the office of chairperson or board member of a Prescribed Body Corporate may give rise to a declarable conflict of interest that must be managed in accordance with the LG Act.

Executive Summary:

In accordance with the Wug decision-making process set out in Council’s Trustee Policy, Expressions of Interest (EOIs) for leases are required to be tabled at a Trustee meeting for noting. Trustee noting of the EOIs occurs following consultation with the Divisional Councillor, the Mualgal (Torres Strait Islanders) Corporation RNTBC and Senpolau Kai Kazil Elders Group. Once the consultation is complete and the Trustee notes the EOIs, they are publicly notified for 4 weeks.

This paper is to request that the Trustee note the EOIs and delegate to the Chief Executive Officer the power to take steps to deal with the disputed applications in accordance with the Trustee Policy.

The Trustee is not required to make a decision at this time.

Background / Previous Council Consideration:

There are 55 EOIs for home ownership leases and 4 EOIs for commercial leases in Wug. The EOIs are to be assessed in accordance with the Trustee Policy, and the decision-making process that applies to Wug must be followed, prior to the Trustee deciding whether or not to grant the leases. The list of EOIs and a map showing their location is attached to this paper. The list and map have also been provided to the Divisional Councillor, the Mualgal (Torres Strait Islanders) Corporation RNTBC and Senpolau Kai Kazil Elders Group. A community meeting for the public notification of the EOIs is scheduled for 24 February 2026.

A summary of the decision-making process for St Pauls is set out below (*clause 7 of the Wug (St Pauls) decision-making process*):

- a. EOI submitted.
- b. Consultation with Divisional Councillor, the PBC and the St Pauls Elders’ Group, with conflicts of interest to be managed under the *Local Government Act 2009* (for TSIRC) and the PBC Rules (for the PBC).
- c. After Divisional Councillor, PBC and St Pauls Elders’ Group consultation, the EOI will be presented to a TSIRC meeting for noting.
- d. Public notification of EOI (for at least 4 weeks).
- e. **No dispute** – TSIRC decision at the next opportunity
- f. **Dispute** – TSIRC will not make a decision for 3 months. In the meantime:
 - i. All people involved in the dispute will be given details of the dispute, including details of other people involved in the dispute.
 - ii. TSIRC will consult again with the Divisional Councillor, the PBC and the Elders’ Group.
 - iii. TSIRC will make a decision about the EOI after 3 months and after consultation. The decision will be whether or not to approve the EOI.

Multiple applications by the same person.

The Trustee will note that there are individuals who have applied for multiple home ownership leases in the community. Council officers will clarify with the applicants, the proposed use of those areas. This will assist the Trustee in making a decision about those EOIs. A home ownership lease is a primary place of residence. If multiple applications for home ownership leases are submitted, the first lease may be a home ownership lease, any additional lease thereafter should be for a different purpose. Further information will be provided to the Trustee in relation to those applications prior to the Trustee being requested to make a decision about them. The Trustee may also decide to limit the number of leases any one person can hold in community.

Disputed/contested applications.

There are disputed/contested applications whereby multiple people have applied for a lease over the same area of land. These applications will require implementation of the dispute process as set out in the Trustee Policy (outlined above). Once the dispute process has been completed, the Trustee will be informed of the outcome and requested to make a decision about the applications. The decision will be whether or not to approve the disputed EOIs.

Native Title consent.

Upon Trustee approval of any of the EOIs, a conditional agreement to lease will be issued to applicants. The conditions will include the requirement for the applicant to obtain Native Title consent prior to the leases being granted. There will likely be other approvals, including agreement on sale prices for any social housing dwellings and in some case, survey and planning approval.

Recommendation

It is recommended that the Trustee note the EOIs and delegate to the Chief Executive Officer the power to take steps to deal with the disputed applications in accordance with the Trustee Policy.




